## ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, Srl Sangameshwar Shikshana Samsthe, Chadchan Plot No. 74, Maradi Street, Chadchan Village and Post Indi, Taluk, Bijapur District-586205, Karnataka had submitted an on-line application to the Southern Regional Committee of NCTE on 28.05.2015 and submitted printouts on 29.05.2015 for grant of recognition for B.Ed Programme of one basic unit of 50 Students at Shri Guru Mallikarjuna College of Education, Chadchan, Plot No. 74, Street No.1, Chadchan Village and Post Office , Indi Taluk, Bijapur District-586205, Karnataka.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to Shri Guru Malilkarjuna College of Education, Chadchan, Plot No. 74 ,Street No.1 ,Chadchan Village and Post Office , Indi Taluk, Bijapur District-586205, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 50 students from the academic sessions 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained Perpetually. Loan raising against or mortgaging of FDR's shall L not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE 11. regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014. III.
- The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in Position. IV.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body. the State Government etc, as applicable 2
- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic
- year along with the statement of annual accounts duly audited by a chartered Accountant. 3

The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter -alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as Ind, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. - e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
